

Information about the Doctoral School Earth Sciences and Environment ED 413 - **Structure**

- 2 research labs (ITES and LIVE)
- 2 Instituts thématiques interdisciplinaires (ITI)
 - GeoT: Geosciences for the Energy transition
 - Sustainability
- 1 out of the 10 doctoral school at Unistra (about 2500 PhD students)

Information about the Doctoral School Earth Sciences and Environment ED 413 - **Composition**

74 doctoral students (29 Women and 45 Men) – 3% of Unistra PhD

18 students in 1^{rst} year (7 W/11 M)
17 students in 2nd year (7 W/10 M)
18 students in 3rd year (7 W/11 M)
14 students in 4th year (4 W/10 M)
5 students in 5th year (3 W/2 M)
2 students in 6th year (1 W/1 M)

Average duration: 3 years and 6 months

- March-April Unistra PhD award, individual training agreement (CIF) <u>completed</u>
- March-June Follow-up committee **done** with report sent to secretary
- **JUNE** selection of PhD students founded by Unistra, Thesis diplomas ceremony
- July-September 2+ year registration, selection of PDI candidates

Year 1

1st registration (financing/doctoral charter/internal regulations)

training agreement set up (Dec-Feb)

Audition by the Follow-up Committee (before **end of June**)

compulsory training: deontology/3h AND integrity seminar/Mooc 10h

Year 2

2nd registration (July to **September 30th**)

Audition by the Follow-up Committee (before **end of June**)

Training

Year 3

3rd registration (July to **September 30th**)

Preparation of defense (training courses, publications, jury)

Audition by the Follow-up Committee (**March-April**) – mandatory if defense expected after Sept. 30th Final training courses

Year 4

4th registration (July to **September 30th**)

- either defense before the end of the current year (Dec. 20): jury submitted
- or extension: proof of funding and opinion of the Monitoring Committee

Convention individuelle de formation (CIF)

Application of the order of May 25, 2016 Modified August 2022

- **Objective:** define and plan the entire doctoral program (research project, individual training plan, composition of the follow-up committee)
- Elle engage le doctorant, son directeur de thèse, le directeur de l'unité de recherche et le directeur de l'école doctorale.
- It may be revised each time you re-register, and must be revised for an derogatory registration (4th year)
- Mandatory for all doctoral students.

Training validation (54 h cross-disciplinary + 54 h specialized)

- Requests for validation of cross-disciplinary or specialized training courses (other than those offered by Unistra) must be made BEFORE the course deadline. The ED will decide whether or not to validate the request, and will allocate a number of hours depending on the workload and interest of the course.
- Seminars and conferences are considered as scientific training, but the number of hours validated is capped at 27 hours (half the total).
- Organizing, leading and popularizing activities are considered cross-disciplinary training. When you submit your application, the ED will request a complete list of training courses taken (with certificates if possible).

Individual Follow-up committee Comité de Suivi Individuel (CSI)

EVERY YEAR between March and June (order of August 2022)

Each doctoral student must have an interview with the follow-up committee **BEFORE** each registration

Composition of the monitoring committee :

- At least 2 teachers/researchers or researchers (emeritus accepted) not involved in the doctoral student's project.
- At least 1 member must hold an HDR.
- At least 1 member of the committee is not involved in the theme.
- If possible, 1 member from outside the unit and/or institution.
- In accordance with the composition defined in the doctoral student's individual training agreement (CIF)

Individual Follow-up committee Comité de Suivi Individuel (CSI)

- The doctoral student presents his/her work to the follow-up committee, then answers questions from committee members.
- The thesis supervisor(s) attend(s) the presentation and discussion. The follow-up committee continues the discussion with an individual interview with the doctoral student and an individual interview with the thesis supervisor(s).
- 1. The follow-up report is signed and sent within 15 days to the doctoral school secretary
- 2. The director of the doctoral school signs, with eventual comments
- 3. The report is sent to the PhD student and supervisor(s)
